#### 4.0 Information/Action

4.1 Desert Mountain SELPA Annual Service Plan (ACTION)

California Education Code requires that an Annual Service Plan be approved by the Community Advisory Committee as part of the Local Plan. The 2023-24 Annual Service Plan describes all special education services currently provided in the Desert Mountain SELPA broken down by type, location and level of severity.

• Heidi explained that this plan is similar to the LCAP in school districts. The Service Plan was approved by the Steering Committee; next step is approval by the CAC. The Plan (section E) lists all services provided by SELPA, which have not changed since they were put in effect. Plan is updated as services are added. We are to consider sections D & E (Annual Services Plan and Budget Plan). The Budget may need a special meeting if budget changes are made at the May Governance Council meeting due to funding streams.

**4.1.1 BE IT RESOLVED** that the Desert Mountain SELPA 2023-24 Annual Service Plan be approved as presented. Motion was made by Nicole Yeager and seconded by Brieseda Ramirez to approve the plan as presented.

- Motion carried and was **<u>approved</u>** unanimously.
- 4.2 Desert Mountain Charter SELPA Annual Service Plan (ACTION)

California Education Code requires that an Annual Service Plan be approved by the Community Advisory Committee as part of the Local Plan. The 2023/24 Annual Service Plan describes all special education services currently provided in the Desert Mountain Charter SELPA broken down by type, location and level of severity.

• This Plan has fewer services because of the geographical locations. Services have not changed in several years. This Budget Plan will not be affected by the May Governance Council meeting.

> • Heidi reiterated that the budget may change based on the Governance Council Meeting on May 12 and the funding source. Depending on what is decided this change could impact the services provided by the Desert Mountain Children's Center. We will know more after the May Governance Council Meeting

- 4.4 Desert Mountain Charter SELPA Annual Budget Plan (ACTION)

California Education Code requires that an Annual Budget Plan be approved by the Community Advisory Committee as part of the Local Plan. The 2023-24 Annual Budget Plan describes the revenues and expenditures for special education for all local education agencies in the Desert Mountain SELPA.

- 4.7 CAC Locations Hosting Districts
  - Heidi commented that our attendance was better when meetings were virtual. When held at Hesperia, attendance was very good because their parent group attended. Cheri again mentioned that perhaps changing the time frame, and/or splitting the presentations from the business meeting, would help increase attendance. Online attendees miss the in person 'tools,' and dinner!
  - Suggestions for items in the next parent survey included: Parent meeting in the morning and Business meeting (virtual) at 5:00pm; presentations recorded so that those unable to attend could watch at a future time. Heidi mentioned that this would depend on the speaker.
  - Heidi asked if any districts would offer to host next year's meetings.... Susan Bennis offered Apple Valley Unified for one of the meetings.
